INTRODUCTION

This Notice informs you of the existence of a collective action lawsuit seeking unpaid overtime wages on behalf of individuals who, during any time after September 15, 2013, worked for SMG Group, LLC or any affiliated company as salaried store managers at convenience stores operating under names such as Joe's Kwik Marts.

You have a right to participate in the lawsuit.

DESCRIPTION OF THE LAWSUIT

In June 2016, a former store manager named Jenny Shiptoski ("Plaintiff") started this lawsuit against SMG Group, LLC ("the company"). Since then, five additional individuals have joined the lawsuit. The lawsuit is proceeding in the United States District Court in Scranton, PA and is assigned to Judge Robert D. Mariani.

The lawsuit alleges that the company violated federal and state wage laws by failing to make overtime payments to salaried store managers who were classified as exempt from overtime requirements by the company when those store managers worked over 40 hours in a week. The lawsuit seeks the recovery of unpaid overtime wages, liquidated damages, attorney's fees and costs.

The company denies all of the allegations and maintains that it properly paid all wages due to Plaintiff and all other store managers. The company asserts that its pay practices are legal.

The lawsuit is in its early stages. The Federal Court has not decided who will win this lawsuit.

RETALIATION PROHIBITED

If you join the lawsuit, federal law prohibits the company from retaliating against you as a result of your participation.

EFFECT OF JOINING THE LAWSUIT

If you join the lawsuit, you will be bound by the judgment of the Federal Court on all issues, including the reasonableness of any settlement or any judgment regarding Plaintiff's wage claims entered in this case, whether favorable or unfavorable.

If you join the lawsuit, you may be required to participate in the "discovery" process by, for example, gathering and producing any work-related documents, answering some written
